The council is looking at restructuring the investments at the church. Motion was made by Sharon to move the monies from Edward Jones to Dane Johnston Financial for consolidation of funds. Dane will set up parameters, give advice and reports, to the appropriate people for managing the account. Vicki Olsen seconded this motion.

Elders report: The volunteer sheets will now be displayed on a magnetic easel that will be placed in the narthex, so all can see it readily and have easy access to signing up.

We continue to work on finding a time to finish up the bylaws.

Liaison report: The memorial committee did not meet in August.
