What if nothing about this time of year gives you the sense that this is the most wonderful time of the year? What if the only thing you can think of is how everything is different this year? This time of the year we are reminded firsthand of the mixed feeling between the loneliness we have found ourselves facing and the promises found in the Advent candles. How do we find light amid so much darkness? As believers we know that God is love and that love came from heaven to earth in human form. How can we honor our feelings of loneliness and grief while making space for love? Is there space to honor both grief and love?

Perhaps we can acknowledge it's different this year. Acknowledging our grief and loss, our pain, our hurt, and our anger. Perhaps we can sit with our loneliness, while also acknowledging the promises found in scripture.

The truth is it doesn't have to be one or the other. Perhaps it requires us to dig deep and acknowledge our pain while also holding onto the promises of Advent. Christmas also challenges us to be that welcoming space. If the light of the world can sit with those who have experienced despair and loss helping them to hold both their grief and their love, then we can sit and listen to one another too. We can show the love of Christ this Advent season. Giving opportunities for Hope, Peace, Joy, and Love while making space for the grief. We are called to love one another through the Christmas season while sharing the Advent message of Hope, Peace, Joy, and Love. Then we can truly proclaim:

Approval of October 6th Minutes: Motion to approve by Kathy Westendorf. Seconded by Jay Ranard.

Treasurer Report: Motion to approve by Conrad Marsh. Seconded by Vicki Oleson.

Trustee Report:

Parsonage rent, October 24th renters reached out and asked us to work with them during this time, other costly repairs/issues came up this month.

Water disconnect is broken to the parsonage, Church's responsibility to repair. Sam Smith Excavating will be coming in to complete, needs repaired by November 30th.

Jay working with a consultant for Church360 to review the ledger system. Looking to get this scheduled this week. They charge per members of the church (294 total members with 127 active members) costs will be \$1,000/year. Grace church uses this software and love it. Jay is confident this would be a great addition to Faith UCC's financial systems. Better tracking, understanding and clear sections for each office personnel. There is a 30-day free trial that we will pursue after Jay and Barb meet with the consultant from Church360 and decide to move forward.

Snow removal – need to call Kevin Holme, last year charge was \$55/time, need to confirm price is the same. Spencer Snelling performs the church parking lot – calling to confirm will still perform this year.

November 30th after church- Trustees will get together to get a budget started.

Ellen Kalkbrenner still interested in backfilling Barb Hill's financial role. Ellen sent in a letter for consideration for this role.

Tree removal still needed at the cemetery, Brad Anthony out of Strawberry Point - insured and will be out to look to give us a quote.

Boiler did not pass inspection; it passed previously but now did not pass. Valves ordered and Ryan still needs to install, waiting on quote.

Elder Report:
