Opening Prayer

Meeting called to order by Dave Kirchhoff

Meeting with St John Siegel: Discussion on sharing a Pastor. Kandy spoke about how to share one pastor with two congregations and how it will look; how will we move forward? There is no set path to be successful in merging. Need to confirm we are a match and we share the same passions, mission and values. There is another church open to join this conversation as well. Conversation is great, nothing set in stone. Will need to be more flexible if sharing a pastor. Could be creative and adjust to the needs of all congregations. Kandy willing to help lead conversations to help direct congregational involvement. Both churches would still complete a profile and it would be stated full time but shared with another church. Profiles are all on-line and will need a start date when posting this profile. Mission, introduction and making our profile authentic to our church and really invite and draw potential Pastors to our Church. Survey being sent to Dave to share with the congregation on what they are willing to be flexible on and what they aren't interested in changing/adapting to. Still need to form a search committee to start the profile. January 12th at 6:30pm is the next meeting with St John Siegel.

Approval of November 3rd Minutes: Motion to approve by Jay Ranard. Seconded by Kathy Westendorf.

Treasurer Report: Motion to approve by Conrad Marsh. Seconded by Bonnie Travers.

Trustee Report: Renters applied for a grant through United Way and they call on supporters to help cover any expenses for families in need. \$1300 received to be put towards past due rent. \$350 more coming to cover the remaining balance and to help cover next months as well.

Church 360 pilot test is starting. There are nine test members. Free month started November 24th. Barb is working on a sample chart of accounts to start reporting and check the ledger etc. Can assign members to specific accounts for the financials. Need a decision before the first of the year to have a clean break. Cost is based on household number not each member.

Thursday 12/4 9am to discuss budget.

Elder Report: Kids singing December 14th, and serving Fellowship that Sunday.

New curriculum for Sunday School geared towards one room learning to accommodate children of all ages with limited volunteer leaders.

Start working on bylaws, confirm vision and mission for our Church and job descriptions for staff.

Hanging of the greens cancelled due to weather—Marlene and Kathy completed the tree and wreaths.

Vicki to continue to schedule pulpit supply, since she has been the main contact thus far.

Mike and Roger leading Christmas service.

Women of Faith Fundraiser was very successful. Over \$3,000 received.

Ash Wednesday – February 18th – working to find pulpit supply to cover this.

Lenten meals will be assigned to committees – Kathy will work to get this scheduled and communicate.

Council members terms expire. How is backfilling to be determined.

Traci, Conrad and Vicki terms expire.

Liaison Report: Kendy Miller from the conference met via zoom to discuss endowments.

Old Business: Pulpit supply going very well. Pastors reaching out to us to look for open Sundays.

New Business: None.

Motion to adjourn by Traci Bahrenfuse. Seconded by Jay Ranard. The meeting was closed with the Lord's Prayer.
